PROPOSALS FOR RE-ELECTION OF DIRECTORS GENERAL MANDATES TO ISSUE AND REPURCHASE SECURITIES AND NOTICE OF ANNUAL GENERAL MEETING

I. INTRODUCTION

At the annual general meeting of the Company held on 25 May 2011, general mandates were given to the Directors to exercise the powers of the Company to repurchase and issue Shares. Such mandates will lapse at the conclusion of the AGM.

The purpose of this circular is to provide you with information regarding the resolutions to be proposed at the Annual General Meeting relating to (i) the re-election of Directors; and (ii) the granting to the Directors of general mandates for the issue and repurchase of Shares up to 20% and 10% respectively of the aggregate nominal amount of the Company's issued share capital as at the date of the passing of the relevant resolutions.

II. RE-ELECTION OF DIRECTORS

As at the date of the circular, the Board comprises seven Directors, namely Mr. Zhang Hong Wei, Mr. Zhu Jun, Ms. Zhang Meiying and Mr. Andrew Leo Kirby, being the executive Directors and Mr. Chau Siu Wai, Mr. San Fung and Mr. Zhu Chengwu, being the independent non-executive Directors.

Pursuant to Bye-law 87(1) of the Bye-laws, notwithstanding any other provisions in the Bye-laws, at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at least once every three years.

Pursuant to Bye-law 87(2) of the Bye-laws, a retiring Director shall be eligible for re-election and shall continue to act as a Director throughout the meeting at which he retires. The Directors to retire by rotation shall include (so far as necessary to ascertain the number of directors to retire by rotation) any Director who wishes to retire and not to offer himself for re-election. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment and so that as between persons who became or were last re-elected Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. Any Director appointed pursuant to Bye-law 86(2) shall not be taken into account in determining which particular Directors or the number of Directors who are to retire by rotation.

Pursuant to Bye-law 86(2) of the Bye-laws, the Directors shall have the power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or, subject to authorization by the Shareholders in general meeting, as an addition to the existing Board but so that the number of Directors so appointed shall not exceed any maximum number determined from time to time by the Shareholders in general meeting. Any Director so appointed by the Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election at that meeting.

Pursuant to Bye-laws 87(1) and 87(2) of the Bye-laws, Mr. Zhang Hong Wei, Mr. Andrew Leo Kirby and Mr. Chau Siu Wai, shall retire by rotation and being eligible, will offer himself for re-election at the Annual General Meeting.

The brief biographical details of the retiring Directors are set out in Appendix I to this circular.

III. GENERAL MANDATES TO ISSUE AND REPURCHASE SECURITIES

At the Annual General Meeting, ordinary resolutions will be proposed to renew or grant the general mandates given to the Directors (i) to allot, issue and otherwise deal with securities not exceeding in aggregate 20% (2,556,775,102 shares) of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of such resolution; (ii) to repurchase securities which does not exceed 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of such resolution; and (iii) to add the aggregate amount of the securities repurchased by the Company to the general mandate to the Directors to allot new securities of up to 20% of the issued share capital of the Company as at the date of passing such resolution.

The mandate to issue Shares granted on 25 May 2011 will lapse at the conclusion of the Annual General Meeting. In this regards, resolution will be proposed at the Annual General Meeting to renew the mandate.

The explanatory statement in connection with the proposed general mandate to repurchase securities (the "**Repurchase Mandate**") is set out in Appendix II to this circular. The explanatory statement contains all the information reasonably necessary to enable Shareholders to make an informed decision on whether to vote for or against the resolution to grant to the Directors the Repurchase Mandate.

IV. ANNUAL GENERAL MEETING

A notice convening the Annual General Meeting is set out on pages 12 to 15 of this circular. At the Annual General Meeting, in addition to the ordinary business of the Meeting, resolutions will be proposed to approve the re-election of Directors, the general mandates for the issue and repurchase by the Company of its own shares.

A form of proxy for use at the Annual General Meetings is also enclosed with this circular. Whether or not you are able to attend the meeting, you are requested to complete the accompanying form of proxy in accordance with the instructions printed thereon and return the same to the office of the Company's branch share registrar and transfer office in Hong Kong, Tricor Secretaries Limited, at 26th Floor, Tesbury Centre, 28 Queen's Road East, Hong Kong, as soon as possible, and in any event not less than 48 hours before the time appointed for holding of the Annual General Meeting or any adjournment thereof. Completion and return of the form of proxy shall not preclude the Shareholders from attending and voting in person at the Annual General Meeting or any adjournment thereof if they so wish.

Pursuant to Bye-law 66 of the Bye-laws, a resolution put to the vote of a meeting shall be decided on a show of hands unless voting by way of a poll is required by the Listing Rules or (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) a poll is demanded as stated in Bye-law 66 of the Bye-laws. Pursuant to Rule 13.39(4) of the Listing Rules, all votes of the Shareholders at the general meetings must be taken by poll. The chairman of the meeting will therefore demand a poll for every resolution put to the vote of the Annual General Meeting pursuant to Bye-law 66 of the Bye-laws.

V. RECOMMENDATION

The Board considers that all the proposed resolutions in relation to (i) re-election of Directors and (ii) the general mandate to issue new shares and (iii) Repurchase Mandate to be put forward at the Annual General Meeting are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Board recommends the Shareholders to vote in favour of all the resolutions to be proposed at the Annual General Meeting.

APPENDIX I BIOGRAPHICAL DETAILS OF RETIRING DIRECTORS

This biographical details of the retiring Directors proposed to be re-elected at the Annual General Meeting are set out as follows:

Mr. Zhang Hong Wei, aged 57, joined the Company on 27 February 1998. Mr. Zhang is the Chairman of the Group. Mr. Zhang is also the chairman and president of Orient Group Inc., Mr. Zhang is also the Deputy Chairman of China Minsheng Banking Corporation Ltd., a joint-stock bank listed on the Shanghai Exchange and on the Stock Exchange of Hong Kong Limited. He has 30 more years of experience in management in the PRC. As at the Latest Practicable Date, Mr. Zhang is beneficially interested in 9,261,950,115 shares of the Company, representing approximately 72.45% of the existing issued share capital of the Company, and is the controlling shareholder of the Company.

There is no service contract entered into between the Company and Mr. Zhang and he is not appointed for a specific term but is subject to retirement by rotation and re-election at the Company's annual general meeting in accordance with the Bye-laws of the Company. The director's fee for Mr. Zhang is HK\$1,000,000 per annum which is determined by reference to his duties and responsibilities in the Company and the remuneration policy of the Company.

Mr. Zhang is the father of Ms. Zhang Meiying, an executive Director of the Company. Save as disclosed above, Mr. Zhang has not held any directorship with other listed companies in the last 3 years. Save as disclosed above, Mr. Zhang does not have any interest or short position in shares, underlying shares or debentures of the Company or any of its associated companies within the meaning of Part XV of the SFO.

Mr. Andrew Leo Kirby, aged 39, joined the Company on 1 June 2011 as an executive Director. Mr. Kirby was working in the resources group of Macquarie Capital (Hong Kong) Limited ("Macquarie") from September 2007 to May 2011. During this time, Mr. Kirby acted as financial advisor to the Company in relation to its landmark announcement of a very substantial acquisition of BP's upstream business in Pakistan. Prior to the role at Macquarie, Mr. Kirby worked in London for Lehman Brothers also in the natural resources group. This followed a 9-year career at BP plc in the United Kingdom, China, Japan and New Zealand in various international business development, strategy and merger & acquisition related roles. Mr. Kirby has gained a deep experience across the energy industry in addition to strong corporate finance and investment banking. He graduated from the University of Canterbury with a Bachelor of Commerce degree in Business Administration. After graduating he studied Mandarin at the National Taiwan Normal University Mandarin Training Centre in Taipei. As at the date of this report, Mr. Kirby has 10,000,000 share options which entitle Mr. Kirby to subscribe for an aggregate 10,000,000 ordinary shares of the Company at an exercise price of HK\$1.15 per share. They were granted to Mr. Kirby on 17 May 2011 under the share option scheme adopted by the Company on 11 May 2006.

With the broad energy industry and investment banking experience, Mr. Kirby also performs the role of Head of Strategy of the Company and is primarily responsible for identifying and executing mergers and acquisitions in line with the stated strategy of the Company and supporting the arrangement of any debt or issuance of equity.

APPENDIX I BIOGRAPHICAL DETAILS OF RETIRING DIRECTORS

Mr. Kirby has entered into a service contract with the Company but has not been appointed for a specific term and his appointment as an executive Director of the Company shall be for an initial term up to the conclusion of the next annual general meeting of the Company, when he will retire in accordance with the Bye-Laws of the Company and, being eligible, may offer themselves for re-election. Thereafter, he will be subject to retirement by rotation and re-election. Mr. Kirby will receive annual salary of SGD 500,000 for his service as an executive Director and the Head of Strategy, M&A, Asset Sales and Investor Relations of the Company, which is determined by the Board based on the recommendation from the remuneration committee of the Company with reference to his qualification, duties and responsibilities with the Company, the Company's performance and the prevailing market conditions. In additional to the above Director's fee, Mr. Kirby is also entitled to a fixed bonus, allowances and a discretionary bonus which is paid in accordance with his performance and contribution to the Company.

Save as disclosed above, Mr. Kirby has not held any directorship with other listed companies in the last 3 years. Save as disclosed above, Mr. Kirby does not have any interest or short position in shares, underlying shares or debentures of the Company or any of its associated companies within the meaning of Part XV of the SFO.

Mr. Chau Siu Wai, aged 42, joined the Company on 9 November 2004 as an independent non-executive Director. Mr. Chau is a university graduate with a bachelor degree in law. He further obtained a master degree in business administration from Murdoch University in Australia. Mr. Chau has 10 more years of experience in financial reporting and investment analysis and is now a duty president of an investment company. Mr. Chau is considered to be an independent non-executive director under Rule 3.13 of the Listing Rules.

There is no service contract entered into between the Company and Mr. Chau and he is not appointed for a specific term but is subject to retirement by rotation and re-election at the Company's annual general meeting in accordance with the Bye-laws of the Company. The director's fee for Mr. Chau as the independent non-executive Director is HK\$120,000 per annum which is determined with reference to his duties and responsibilities in the Company and the remuneration policy of the Company.

Save as disclosed above, Mr. Chau confirms that he has not held any directorship in any company listed on the Stock Exchange or other stock exchanges in the last three years and do not has any relationship with any director, senior management, substantial shareholders or controlling shareholders of the Company. As at the Latest Practicable Date, Mr. Chau has never held any position with the Company or its subsidiaries and he does not have any interest or short position in shares, underlying shares or debentures of the Company or any of its associated companies within the meaning of Part XV of the SFO.

The above Directors confirm that there is no information to be disclosed pursuant to any of the requirements under Rule 13.51(2)(h) to (v) of the Listing Rules nor are there other matters that need to be brought to the attention of the Shareholders.

APPENDIX II EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

This Appendix contains the particulars that are required by the Listing Rules to be included in an explanatory statement to enable the Shareholders to make an informed view on whether to vote for or against the resolution to be proposed at the Annual General Meeting in relation to the Repurchase Mandate.

SHARE CAPITAL

As at the Latest Practicable Date, the number of Shares in issue was 12,783,875,512.

Subject to the passing of the resolution granting the proposed mandate to repurchase the securities and on the basis that no further Shares are issued or repurchased before the Annual General Meeting, the Company will be allowed to repurchase a maximum of 1,278,387,551 Shares, representing 10% of the issued share capital of the Company at the Latest Practicable Date, during the period ending on the earlier of the conclusion of the next annual general meeting of the Company is required to be held by law or the date upon which such authority is revoked or varied by a resolution of the Shareholders in general meeting.

REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders as a whole to seek a general authority from the Shareholders to enable the Company to repurchase its securities on the Stock Exchange. The Mandate, once approved, would give the Company the flexibilities to undertake the buy-back of the Shares at any time, subject to market conditions, during the period when the Mandate is in force. Further, among others, Shares repurchase provide the Company with a mechanism to facilitate the return of surplus cash over and above its ordinary capital requirements in an expedient and cost-efficient manner. The Directors believe the Share repurchase may help to mitigate against short term volatility of share price and offset the effects of short term speculation. Such repurchases may, depending on market conditions and funding arrangements at the time, enhance the net assets value of the Company and/or earnings per Share and the repurchase will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders.

The Directors have no present intention to repurchase any Shares of the Company and they would only exercise the power to repurchase in circumstances where they consider that the repurchase would be in the best interests of the Company and in circumstances where they consider that the Shares can be repurchased on the terms favourable to the Company. As compared with the financial position of the Company as at 31 December 2011, being the date of its latest published audited accounts, the Directors consider that if the Repurchase Mandate were to be exercised in full during the proposed repurchase period, there will be a material adverse impact on the working capital position and gearing level of the Company. The Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital or the gearing level as compared with the position disclosed in the latest published audited accounts of the Company which, in the opinion of the Directors, are from time to time appropriate for the Company.

APPENDIX II EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

FUNDING OF REPURCHASES

Repurchases to be made pursuant to the Repurchase Mandate would be financial out of funds legally available for the purpose in accordance with the bye-laws and the applicable laws in Hong Kong and Bermuda. Such funds include, but are not limited to, profits available for distribution.

EFFECT OF THE TAKEOVERS CODE AND REPURCHASE CODE

Upon the exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of Rule 32 of the Takeovers Code and Rule 6 of the Repurchase Code. Accordingly, a Shareholder or group of Shareholders acting in concert, depending on the level of increase of the Shareholders' interest, could obtain or consolidate control of the Company and, depending on the level of increase of the Shareholders' interest, may become obliged to make a mandatory general offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, according to the register maintained by the Company pursuant to Section 336 of the SFO, the following substantial shareholders were interested in 5% or more of the issued share capital of the Company:
