### **ISSUE OF NEW SHARES UNDER THE SHARE MATCH SCHEME FOR SCHEME YEAR 2016**

In relation to the Employees' participation to the Scheme for Scheme Year 2016, on 11 November 2016, the Board resolved to award 21,703,384 new Shares as the Scheme Shares to 557 Participating Employees by way of issue and allotment of new Shares of the Company pursuant to the Scheme under the General Mandate.

The Company will arrange the subscription money for the subscription of 21,703,384 new Scheme Shares at HK\$0.255 per Scheme Shares from the Company's resources. Upon allotment of the new Scheme Shares, the Trustee will hold them on trust for the Participating Employees and will transfer them to the Participating Employees at no cost to the Participating Employees upon all vesting conditions specified by the Board having been satisfied.

Reference is made to the announcement of the Company dated 16 September 2011 in relation to the adoption of the Scheme by the Board on 16 September 2011 and the announcements of the Company dated 10 January 2012, 22 October 2012, 24 October 2013, 31 October 2014 and 23 October 2015 in relation to issue of new Shares under the Scheme.

In September 2016, the Employer issued an invitation letter to each of the Employees in accordance with the Scheme Rules to invite the Employees to enrol and participate in the Scheme for Scheme Year 2016. The Employer received from the Participating Employees their replies to enrol and participate in the Scheme together with their confirmation as to the sum of the Employee Contribution Amount which each Participating Employee is desirous of contributing to the Scheme for Scheme Year 2016 and their confirmation as to whether they wish to apply to the Employer for an interest-free instalment loan for the payment of the Employee Contribution Amount, to be repaid to the Employer on monthly basis and out of their salary.

Based on the replies from the Participating Employees, there are 557 Participating Employees enrolling and participating in the Scheme for Scheme Year 2016 and the total sum of the Employee Contribution Amount and the corresponding sum of the Employer Contribution Amount of all the Participating Employees for Scheme Year

2016 has been calculated, and taking reference to the closing price of the Shares as at 1 September 2016 in accordance with the Scheme Rules, the Company has ascertained that the aggregate number of the Scheme Shares to which all the Participating Employees are entitled for Scheme Year 2016 is 21,703,384 Scheme Shares.

For the purpose of the Scheme for Scheme Year 2016, the Board on 11 November 2016 resolved to issue and allot 21,703,384 new Shares as the Scheme Shares to the Trustee at HK\$0.255 per Share (which is the same as the closing price of the Shares as at 1 September 2016 in accordance with the Scheme Rules) pursuant to the terms of the Scheme under the General Mandate.

Immediately prior to the issue of 21,703,384 new Shares as the Scheme Shares, the unutilised portion of the General Mandate is 2,600,871,545 shares which the Board may issue and allot. As only 21,703,384 new Shares are to be issued and allotted under the General Mandate, which is less than the unutilised portion of the General Mandate, such issue and allotment is not subject to further Shareholders' approval.

The Company will arrange the subscription money of HK\$5,534,362.92 for the subscription of 21,703,384 new Scheme Shares from the Company's resources. Upon allotment of the new Scheme Shares, the Trustee will hold them on trust for the Participating Employees and will transfer them to the Participating Employees at no cost to the Participating Employees upon all vesting conditions specified by the Board having been satisfied in accordance with the Scheme Rules.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, the Trustee and all the Participating Employees enrolling and participating in the Scheme for Scheme Year 2016 and their respective ultimate beneficial owners (if applicable and if any) are third parties independent of the Company and connected persons of the Company.

The 21,703,384 new Scheme Shares to be issued and allotted by the Company to the Trustee represent approximately (a) 0.834% of the maximum number of Shares that can be issued and allotted under the General Mandate; (b) 0.083% of the existing issued share capital of the Company as at the date of this announcement; and (c) 0.083% of the issued share capital of the Company as enlarged by the issue and allotment of the new Scheme Shares.

The new Scheme Shares, when issued and fully paid, will rank pari passu among themselves and with those Shares in issue, with the right to receive all dividends and other distributions declared, made or paid on or after the date of allotment.

Application will be made by the Company to the Stock Exchange for granting of the listing of, and permission to deal in, the aggregate 21,703,384 new Scheme Shares.

As at the date of this announcement, save for the issue and allotment of the 21,703,384 new Scheme Shares under the Scheme for Scheme Year 2016 and issue and allotment of the 16,272,730 new Scheme Shares under the Deferred Annual Bonus Scheme, the Executive Performance Share Scheme and the Performance Share

Scheme for the scheme year from 1 January 2016 to 31 December 2016 on 25 July 2016, the Company has not issued or allotted any new Shares under the General Mandate.

Reasons for the issue:	For better utilisation of the resources of the Company, the issue is to make available the Scheme Shares for granting to the Participating Employees under the Scheme, which forms part of the incentive schemes of the Company that retain the Employees for the continual operation in Pakistan and development of the Group and to attract suitable personnel for the growth and further development of the Group.
Identity of the allottee:	The Trustee, which will hold the Scheme Shares in trust in accordance with the Amended and Restated Trust Deed for 557 Participating Employees, being all the Participating Employees who enrolled and participated in the Scheme for Scheme Year 2016.

Market price of the Shares:	The closing price of the Shares as at 1 September 2016 as quoted on the Stock Exchange is HK\$0.255 per Share.
Fund raising activities in the past 12 months:	<p>1. On 12 July 2016, the Board awarded 16,272,730 Shares under the Deferred Annual Bonus Scheme, the Executive Performance Share Scheme and the Performance Share Scheme for the scheme year from 1 January 2016 to 31 December 2016 without funds raised. The issue and allotment of the 16,272,730 Shares were completed on 25 July 2016.</p> <p>2. On 22 July 2016, a shareholder resolution was passed in the special general meeting of the Company to approve for the proposed issue of 13,101,994,107 offer shares to the qualifying shareholders at the subscription price of HK\$0.20 per shares on the basis of one share for every one share in issue (“Open Offer”). The net proceeds of the Open Offer after the deduction of related expenses are approximately HK\$2,578,400,000. The Open Offer was completed on 30 August 2016.</p> <p>Save as disclosed above, the Company has not raised any funds on issue of equity securities in the 12 months immediately preceding this announcement.</p>

## Definition

- “Company” means United Energy Group Limited, a company incorporated in the Cayman Islands and continued in Bermuda with limited liabilities, the shares of which are listed on the main board of the Stock Exchange.

“Director(s)”	means the director(s) of the Company.
“Employee”	means any employee of the Employer whether part time or full time and whether becoming the employee of the Employer before or after the Adoption Date.
“Employer”	means United Energy Pakistan Limited, a company incorporated in the Republic of Mauritius, being an indirect wholly own subsidiary of the Company.
“Employee Contribution Amount”	means the sum of money from time to time contributed by the Participating Employee for the participation in the Scheme.
“Employer Contribution Amount”	means the sum of money from time to time paid by the Company out of its resources equivalent to the sum of the Employee Contribution Amount.
“General Mandate”	means the general mandate granted by the Shareholders at the annual general meeting of the Company held on 27 May 2016, under which the Directors may issue and allot up to 2,617,144,275 Shares.
“Group”	means the Company and its Subsidiaries (including the Employer) and “member of the Group” shall be construed accordingly.
“HK\$”	means Hong Kong dollars, the lawful currency of Hong Kong.
“Hong Kong”	means the Hong Kong Special Administrative Region of the People’s Republic of China.
“Listing Rules”	means the Rules Governing the Listing of Securities on the Stock Exchange as amended, modified or supplemented from time to time.
“Participating Employees”	means the Employees agreeing in writing to participate to the Scheme for Scheme Year 2016 in accordance with the Scheme Rules.
“Scheme”	means the share match scheme of the Company approved and adopted by the Board on the Adoption Date, in its present form or as amended from time to time in accordance with the Scheme Rules.
“Scheme Rules”	means the rules relating to the Scheme, as amended, modified or supplemented from time to time.

“Scheme Shares”	means the Shares from time to time acquired for the Participating Employees.
“Scheme Year 2015”	means the Scheme Year starting from 1 September 2015 to 31 August 2016.
“Scheme Year 2016”	means the Scheme Year starting from 1 September 2016 to 31 August 2017.
“Shareholder(s)”	means the shareholders of the Company.
“Share(s)”	means ordinary shares of HK\$0.01 each in the share capital of the Company.
“Stock Exchange”	means The Stock Exchange of Hong Kong Limited.
“Subsidiaries”	means companies which are for the time being and from time to time subsidiaries (within the meaning of section 2 of the Companies Ordinance (Cap.32 Laws of Hong Kong)) of the Company, whether incorporated in Hong Kong or elsewhere.
“Amended and Restated Trust Deed”	means the amended and restated trust deed dated 24 February 2015 entered into between the Company and the Trustee (as restated, supplemented and amended from time to time) in respect of, inter alia, the constitution of the employee share trust pursuant to the Scheme and the appointment of the Trustee for the administration of the Scheme.
