## PROPOSALS FOR RE-ELECTION OF DIRECTORS GENERAL MANDATES TO ISSUE AND REPURCHASE SECURITIES AND

#### NOTICE OF ANNUAL GENERAL MEETING

#### I. INTRODUCTION

At the annual general meeting of the Company held on 20 April 2018, general mandates were given to the Directors to exercise the powers of the Company to repurchase and issue Shares. Such mandates will lapse at the conclusion of the Annual General Meeting.

The purpose of this circular is to provide you with information regarding the resolutions to be proposed at the Annual General Meeting relating to, inter alia, (i) the re-election of Directors and (ii) the granting to the Directors of general mandates for the issue and repurchase of Shares up to 20% and 10% respectively of the aggregate nominal amount of the Company's issued share capital as at the date of the passing of the relevant resolutions.

#### II. RE-ELECTION OF DIRECTORS

As at the date of the circular, the Board comprises five Directors, namely Mr. Zhang Hong Wei and Ms. Zhang Meiying, being the executive Directors, and Mr. Chau Siu Wai, Mr. San Fung and Ms. Wang Ying, being the independent non-executive Directors.

Pursuant to Bye-law 87(1) of the Bye-laws, notwithstanding any other provisions in the Bye-laws, at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at least once every three years.

Pursuant to Bye-law 87(2) of the Bye-laws, a retiring Director shall be eligible for re-election and shall continue to act as a Director throughout the meeting at which he retires. The Directors to retire by rotation shall include (so far as necessary to ascertain the number of directors to retire by rotation) any Director who wishes to retire and not to offer himself for re-election. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment and so that as between persons who became or were last re-elected Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. Any Director appointed by Directors pursuant to Bye-law 86(2) shall not be taken into account in determining which particular Directors or the number of Directors who are to retire by rotation.

Pursuant to Bye-law 86(2) of the Bye-laws, the Directors shall have the power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or, subject to authorization by the Shareholders in general meeting, as an addition to the existing Board but so that the number of Directors so appointed shall not exceed any maximum number determined from time to time by the Shareholders in general meeting. Any Director so appointed to fill a casual vacancy shall hold office only until the next following general meeting and only Director so appointed as an addition to the Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election at that meeting.

The Nomination Committee reviews the structure, size and diversity annually and recommends any proposed changes to the Board. The Nomination Committee also reviews and recommends any suitable candidate to the Board for it to consider and make recommendations to shareholders for election as Directors of the Company at general meetings or appoint as directors to fill causal vacancies. The Board has considered the business experience, public board experience, diversity, standing, time commitment as well as independence (if applicable) of each candidate.

Pursuant to Bye-laws 87(1) and 87(2) of the Bye-laws, Ms. Zhang Meiying, Mr. San Fung and Mr. Chau Siu Wai, shall retire by rotation and each being eligible, will offer themselves for re-election at the Annual General Meeting.

The Nomination Committee has evaluated the performance of Ms. Zhang Meiying and was of a view that she has been contributing to the Group effectively and are committed to her roles as Director. The Nomination Committee is also of the view that Ms. Zhang would bring to the Board her own perspective, skills and experience, as further described in her biographical details in Appendix I of this circular. Based on the board diversity policy adopted by the Company, the Nomination Committee considers that Ms. Zhang can contribute to the diversity of the Board, in particular, with her educational background and professional and industry experience and connections in various industries. Thus, the Nomination Committee has recommended to the Board and the Board approved the re-election of Ms. Zhang at the AGM.

In addition, each of Mr. San Fung and Mr. Chau Siu Wai has being serving as an independent non-executive Director for more than nine year. In compliance with Code A.4.3 of the Code on Corporate Governance, each of Mr. San Fung and Mr. Chau Siu Wai offered themselves for re-election at the Annual General Meeting. Each of Mr. San and Mr. Chau meets the independent guidelines set out in Rule 3.13 of the Listing Rules. With their in-depth understanding of the Company's operation and business accumulated throughout the years, the Board are of the view that the Board is of the view that Mr. San and Mr. Chau have made objective and constructive advices on the strategy and business development of the Company, and have given independent yet informed guidance to the Company leveraging on their management experience and through their active participation in discussions in and outside of the Board meetings. Each of them demonstrates a firm commitment to his independent role. Each of the Nomination Committee and the Board is satisfied that the long service of Mr. San and Mr. Chau would not affect their exercise of independent judgement and that each of them has the required integrity, character and experience and commitment required from the role of independent non-executive Director and made contribution to the diversity of the Board. Hence, the Board considered Mr. San and Mr. Chau as independent and should be re-elected at the AGM.

The brief biographical details of the retiring Directors are set out in Appendix I to this circular.

If the resolutions of the re-election of the Directors are passed at the AGM, the combination of the Board will the following advantages:

- Two Executive Directors (Mr. Zhang Hong Wei and Ms Zhang Meiying) are having solid industry network and corporate finance and corporate management experience;
- One Independent Non-Executive Director (Ms. Wang Ying) has solid financial and accounting experience; and
- Two Independent Non-Executive Directors (Mr. San Fung and Mr. Chau Siu Wai) have strong corporate management experience.

#### III. GENERAL MANDATES TO ISSUE AND REPURCHASE SECURITIES

At the Annual General Meeting, ordinary resolutions will be proposed to renew or grant the general mandates given to the Directors (i) to allot, issue and otherwise deal with securities not exceeding in aggregate 20% (5,254,132,241 shares based on 20% of the issued number of the issued Share as at the Latest Practicable Date) of the number of the issued Share in issue as at the date of passing of such resolution; (ii) to repurchase securities which does not exceed 10% of the number of the issued Share as at the date of passing of such resolution; and (iii) to add the number of the issued securities repurchased by the Company to the general mandate to the Directors to allot new securities of up to 20% of the number of the issued Share as at the date of passing such resolution.

The mandate to issue Shares granted on 20 April 2018 will lapse at the conclusion of the Annual General Meeting. In this regard, resolution will be proposed at the Annual General Meeting to renew the mandate.

The explanatory statement in connection with the proposed general mandate to repurchase securities (the "Repurchase Mandate") is set out in Appendix II to this circular. The explanatory statement contains all the information reasonably necessary to enable Shareholders to make an informed decision on whether to vote for or against the resolution to grant to the Directors the Repurchase Mandate.

#### IV. ANNUAL GENERAL MEETING

The Annual General Meeting of the Company will be held on Thursday, 30 May 2019. For determining the entitlement to attend and vote at the Annual General Meeting, the register of members of the Company will be closed from Monday, 27 May 2019 to Thursday, 30 May 2019, both days inclusive, during which period no transfer of shares will be effected. In order to be eligible to attend and vote at the Annual General Meeting, all transfers of shares, accompanied by the relevant share certificates, must be lodged with the Company's share registrar in Hong Kong, Tricor Secretaries Limited, at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong before 4:30 p.m. on Friday, 24 May 2019.

A notice convening the Annual General Meeting is set out on pages 14 to 18 of this circular. At the Annual General Meeting, in addition to the ordinary business of the Meeting, resolutions will be proposed to approve the re-election of Directors and the general mandates for the issue and repurchase by the Company of its own shares.

A form of proxy for use at the Annual General Meetings is also enclosed with this circular. Whether or not you are able to attend the meeting, you are requested to complete the accompanying form of proxy in accordance with the instructions printed thereon and return the same to the office of the Company's branch share registrar and transfer office in Hong Kong, Tricor Secretaries Limited, at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong, as soon as possible, and in any event not less than 48 hours before the time appointed for holding of the Annual General Meeting or any adjournment thereof. Completion and return of the form of proxy shall not preclude the Shareholders from

attending and voting in person at the Annual General Meeting or any adjournment thereof if they so wish and, in such event, the instrument appointing a proxy shall be deemed to be revoked.

Pursuant to Bye-law 66 of the Bye-laws, a resolution put to the vote of a meeting shall be decided on a show of hands unless voting by way of a poll is required by the Listing Rules or (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) a poll is demanded as stated in Bye-law 66 of the Bye-laws. Pursuant to Rule 13.39(4) of the Listing Rules, all votes of the Shareholders at the general meetings must be taken by poll. The chairman of the meeting will therefore demand a poll for every resolution put to the vote of the Annual General Meeting pursuant to Bye-law 66 of the Bye-laws.

The Board confirms that to the best of their knowledge, information and belief having made all reasonable enquiries, as at the Latest Practicable Date, there was no voting trust or other agreement or arrangement or understanding (other than an outright sale) entered into by or binding upon any Shareholder and there was no obligation or entitlement of any Shareholder whereby he has or may have temporarily or permanently passed control over the exercise of the voting right in respect of his Shares to a third party, either generally or on a case-by-case basis.

#### V. Recommendation

The Board considers that all the proposed resolutions in relation to (i) re-election of Directors, (ii) the general mandate to issue new shares and (iii) Repurchase Mandate to be put forward at the Annual General Meeting are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Board recommends the Shareholders to vote in favour of all the resolutions to be proposed at the Annual General Meeting.

#### VI. General

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, no Shareholder is required to abstain from voting on any resolutions to be proposed at the AGM.

Ms. Zhang is the daughter of Mr. Zhang Hong Wei, the Chairman, executive Director and controlling shareholder of the Company. Save as disclosed above, Ms. Zhang confirms that she has not held any directorship in any company listed on the Stock Exchange or other stock exchanges in the last three years and do not has any relationship with any director, senior management, substantial shareholders or controlling shareholders of the Company. As at the Latest Practicable Date, save as disclosed above, Ms. Zhang does not have any interest or short position in shares, underlying shares or debentures of the Company or any of its associated companies within the meaning of Part XV of the SFO.

Mr. San Fung, aged 54, joined the Company on 9 November 2004 as an independent non-executive Director. He completed a course in Master of Business Administration from the International East-western University of the United States and a course of EMBA from Cheung Kong Graduate School of Business and was awarded a master degree. He specialized in financial analysis in infrastructure project and has over 21 years of experience in accounting. Mr. San is currently the chairman of Shenzhen Jin Xun Investment Development Company Limited.

There is no service contract entered into between the Company and Mr. San and he is not appointed for a specific term but is subject to retirement by rotation and re-election at the Company's annual general meeting in accordance with the Bye-laws of the Company. The director's fee for Mr. San as the independent non-executive Director is HK\$120,000 per annum which is determined with reference to his duties and responsibilities in the Company and the remuneration policy of the Company.

Save as disclosed above, Mr. San confirms that he has not held any directorship in any company listed on the Stock Exchange or other stock exchanges in the last three years and do not has any relationship with any director, senior management, substantial shareholders or controlling shareholders of the Company. As at the Latest Practicable Date, Mr. San has never held any position with the Company or its subsidiaries and he does not have any interest or short position in shares, underlying shares or debentures of the Company or any of its associated companies within the meaning of Part XV of the SFO.

APPENDIX I

Mr. Chau Siu Wai, aged 49, joined the Company on 9 November 2004 as an independent non-executive Director. Mr. Chau obtained a master degree in business administration from Murdoch University in Australia. Mr. Chau has over 15 years of experience in financial reporting and investment analysis and is now the managing director of an investment company.

There is no service contract entered into between the Company and Mr. Chau and he is not appointed for a specific term but is subject to retirement by rotation and re-election at the Company's annual general meeting in accordance with the Bye-laws of the Company. The director's fee for Mr. San as the independent non-executive Director is HK\$120,000 per annum which is determined with reference to his duties and responsibilities in the Company and the remuneration policy of the Company.

Save as disclosed above, Mr. Chau confirms that he has not held any directorship in any company listed on the Stock Exchange or other stock exchanges in the last three years and do not has any relationship with any director, senior management, substantial shareholders or controlling shareholders of the Company. As at the Latest Practicable Date, Mr. Chau has never held any position with the Company or its subsidiaries and he does not have any interest or short position in shares, underlying shares or debentures of the Company or any of its associated companies within the meaning of Part XV of the SFO.

The above Directors confirm that there is no information to be disclosed pursuant to any of the requirements under Rule 13.51(2)(h) to (v) of the Listing Rules nor are there other matters that need to be brought to the attention of the Shareholders.

EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

This Appendix contains the particulars that are required by the Listing Rules to be included in an explanatory statement to enable the Shareholders to make an informed view on whether to vote for or against the resolution to be proposed at the Annual General Meeting in relation to the Repurchase Mandate.

#### SHARE CAPITAL

As at the Latest Practicable Date, the number of Shares in issue was 26,270,661,209 Shares.

Subject to the passing of the resolution granting the proposed mandate to repurchase securities and on the basis that no further Shares are issued or repurchased before the Annual General Meeting, the Company will be allowed to repurchase a maximum of 2,627,066,120 Shares, representing 10% of the number of the issued Share at the Latest Practicable Date, during the period ending on the earlier of the conclusion of the next annual general meeting of the Company or the date by which the next annual general meeting of the Company is required to be held by law or the date upon which such authority is revoked or varied by a resolution of the Shareholders in general meeting.

#### REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders as a whole to seek a general authority from the Shareholders to enable the Company to repurchase its securities on the Stock Exchange. The Repurchase Mandate, once approved, would give the Company the flexibilities to undertake the buy-back of the Shares at any time, subject to market conditions, during the period when the Mandate is in force. Further, among others, Shares repurchase provide the Company with a mechanism to facilitate the return of surplus cash over and above its ordinary capital requirements in an expedient and cost-efficient manner. The Directors believe the Share repurchase may help to mitigate against short term volatility of share price and offset the effects of short term speculation. Such repurchases may, depending on market conditions and funding arrangements at the time, enhance the net assets value of the Company and/or earnings per Share and the repurchase will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders.

The Directors have no present intention to repurchase any Shares of the Company and they would only exercise the power to repurchase in circumstances where they consider that the repurchase would be in the best interests of the Company and in circumstances where they consider that the Shares can be repurchased on the terms favourable to the Company. As compared with the financial position of the Company as at 31 December 2018 being the date of its latest published audited accounts, the Directors consider that if the Repurchase Mandate were to be exercised in full during the proposed repurchase period, there will be a material adverse impact on the working capital position and gearing level of the Company. The Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital or the gearing level as compared with the position disclosed in the latest published audited accounts of the Company which, in the opinion of the Directors, are from time to time appropriate for the Company.

#### **FUNDING OF REPURCHASES**

Repurchases to be made pursuant to the Repurchase Mandate would be financed out of funds legally available for the purpose in accordance with the Bye-laws and the applicable laws in Hong Kong and Bermuda. Such funds include, but are not limited to, profits available for distribution.

#### EFFECT OF THE TAKEOVERS CODE AND REPURCHASE CODE

Upon the exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of Rule 32 of the Takeovers Code and Rule 6 of the Repurchase Code. Accordingly, a Shareholder or group of Shareholders acting in concert, depending on the level of increase of the Shareholders' interest, could obtain or consolidate control of the Company and, depending on the level of increase of the Shareholders' interests, may become obliged to make a mandatory general offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, according to the register maintained by the Company pursuant to Section 336 of the SFO, the following substantial shareholders were interested in 5% or more of the issued share capital of the Company:

The Directors have no present intention to exercise the Repurchase Mandate to such an extent that would make the public float of the Shares be less than 25%.
